Shipping to the Hotel

Items shipped to the hotel can arrive five (5) calendar days prior to the start of the event. Please schedule your shipments to arrive no earlier than Saturday, April 11. Items received earlier will incur additional charges.

Boxes/pallets MUST be labeled clearly. Legibly mark, in waterproof print/label, on top and one side of each box/pallet. Handling charges each way will apply to all incoming and outgoing boxes as noted below:
